Membership is open to Brough owners, riders and anyone interested in Broughs. Applications should be sent to the Membership Secretary, together with the first annual subscription, entry fee and the postage supplement, if applicable. An information pack is sent to acknowledge receipt of subscriptions and the first Newsletter will follow. Family members are welcome for a small extra fee.

The monthly Newsletter or Magazine is published both in paper form and available on-line for a reduced fee. It contains technical, historical and other articles, details of Club events, other news and advertisements (for sale and wanted). Advertisements can be placed in the Newsletter free of charge to Members. The Editor always welcomes hints such as ‘Where to get it done’ and ‘Where to buy’ for publication.

The Club’s main event is the Annual Rally held during August. Local rallies and social meetings are held throughout the year at various places. The Club is run by a committee, appointed at the A.G.M.

A Spares Scheme, operated by the associated company Brough Superior Club (Spares and Events) Ltd., is in operation for most cycle parts and castings and spares for JAP and Matchless engines.
